The total number of sections taken together for classes XI and XII should not be more than 1/3 of optimum number of section allowed on the basis of land holding for any school.

The number of sections and students shall be restricted as per the actual facilities in the school.

For class rooms of size less than 500 sq feet the enrolment shall be 0.08 X size of class rooms in sq feet

Important Notes: 1. Since the school has submitted to have 22 rooms with the specified dimensions on the school letterhead. Therefore, the total number of section of the school shall be restricted to 22 as per the number of class rooms submitted by the school.

- 2. The School is directed to construct partitions in the boys toilets and submit compliance within 3 months.
- 3. Head of sexual harassment committee is a male member. Thus. The school is required to replace the same with female member and submit the compliance within 03 months.
- 4. The school is required to implement the EPF facility for its staff members and submit the compliance within 03 months.
- 5. Ramp and toilets for CWSN are not covered in the video. Thus, the school is directed to maintain / construct the ramp on ground level, ramp / lift to access upper floor and separate toilets for girls and boys on every floor with proper infrastructural facilities in accordance with the provisions laid down in RPWD Act, within 03 months and submit the compliance.
- 6. The school shall follow the SoPs issued by the Board in respect of labs, library and sports facilities.
- 7. The school shall conduct training of its teachers with respective CoE within 3 months and submit the compliance.
- 8. The school shall get all the mandatory certificates renewed periodically.
- 9. The school shall not remove the videography links in the mandatory disclosure section of its website
